Lead nitrate (10099-74-8) 3% or less and Water (7732-18-5) 97% or more.

SECTION 3 — HAZARDS IDENTIFICATION

Clear, colorless aqueous solution. Odorless.

Inorganic lead compounds are probable human carcinogens (IARC-2A).

Moderately toxic by ingestion and inhalation. Irritating to eyes, skin and mucous membranes. Avoid all body tissue contact. Chronic exposure to inorganic lead via inhalation or ingestion can result in accumulation in and damage to the soft tissues and bones.

SECTION 4 — FIRST AID MEASURES
